

2009 ENERGY STAR New Homes Homebuilder Rebate Request Form

The Governor's Energy Office (GEO) is pleased to provide a \$300 per home rebate to all Colorado homebuilders who construct certified ENERGY STAR New Homes and meet the rebate eligibility requirements for 2009.

Rebate Eligibility Requirements:

1. Rebate is only offered to homebuilders.
2. Rebate is only offered to ENERGY STAR qualifying new homes.
3. Rebate is issued on a per-home basis, and is limited to \$300 per address.
4. Rebate is only offered for ENERGY STAR homes when a utility rebate is not available to the homebuilder. The GEO requires that homebuilders participate in their local utility program if one is offered.
5. Rebate is not available for existing homes.
6. Rebate is only offered to homes that have been completed and have earned the ENERGY STAR label from a RESNET approved HERS Rater.
7. Rebate is only offered to homes that have been "tested." Homes that earn the ENERGY STAR label through the "sampling" protocol are not eligible for this rebate offer.
8. Rebate is offered to homes that are certified as ENERGY STAR between March 1, 2009 and December 31, 2009.
9. Rebate is offered to homes that achieve both a qualifying HERS Score and meet the Thermal Bypass Checklist requirements.
10. A copy of the official Home Energy Rating Certificate for the home must be attached to this form.
11. A separate rebate form must be submitted for each qualifying ENERGY STAR New Home.
12. Failure to provide required information may result in denial of rebate.
13. Rebates are limited to \$300 per address.
14. Rebate is offered on a first-come, first-served basis until program funds have been depleted.
15. The GEO reserves the right to inspect the material and work for each rebate. If a project does not have the qualifying material or work installed, the homebuilder may be required to pay the rebate back and may be deemed ineligible to receive future rebates.

I understand that the GEO is providing a \$300 rebate for the construction of a qualifying ENERGY STAR New Home. The GEO is not responsible for the home's energy performance or predicted energy savings, and does not provide warranties or guarantees, expressed or implied. I certify that the information provided with this application is true and that this address meets all of the rebate eligibility requirements.
